The sensitive personal information we collect under the service scenario of test drive booking belongs to the personal information necessary for the conclusion and implementation of the test drive agreement.
0	If you agree to us providing the service of signing the vehicle purchase intention agreement in Section 1.4.3, we can collect your ID number or passport number through in-app collection, user input or offline collection. The sensitive personal information we collect under the service scenario of signing the vehicle purchase intention agreement belongs to the personal information necessary for the conclusion and implementation of the vehicle purchase intention agreement.
0	If you agree to us providing vehicle purchase services in Section 1.4.4, we can collect your ID number or passport number , bank account number and transaction information through in-app collection, user input or offline collection. If the vehicle buyer is an institution, you agree that we could collect the identity document number of the legal representative of the organization. The sensitive personal information we collect in the service scenario of purchasing vehicle belongs to the personal information necessary for the conclusion and implementation of the vehicle purchase contract.
0	If you obtain basic services of automotive finance and insurance support described in Section 1.4.5 from a qualified supplier we work with, you agree that we can collect your ID number through in-app collection, user input or offline collection.
0	If the existing basic automotive finance and insurance services do not meet your requirements, you agree that for the purpose of assisting us in analyzing and designing automotive finance products that meet your needs and providing it as a reference to the auto financial service providers, we may collect your ID number , front and back images of ID card , real estate status, tax status, bank account opening status, payment information, credit information, insurance policies, vehicle purchase contracts, loan contracts, registration certificate information, vehicle license information, vehicle location information.
0	If you agree to us providing the vehicle-connected network card service in Section 1.4.6, we can collect your ID number and your front-facing , bareheaded photograph through offline collection. When the vehicle buyer is an organization, you agree that we may collect

	front and back images of ID card and front-facing, bareheaded photograph of the person responsible for the vehicle designated by the vehicle purchasing organization. The sensitive personal information we collect under the service scenario of the vehicle-connected network card belongs to the personal information necessary for us to fulfill our legal obligations.
0	If you agree to us providing charging pile installation service in Section 1.4.7, we can collect your recordings in-app or offline.
0	If you agree to us providing the account transfer service in the OnStar service in Section 1.5.1, we can collect your vehicle license , ID number and photos of you holding these two documents offline for the account transfer.
0	If you agree to us providing OnStar services in Section 1.5.1, we can collect your vehicle location information and vehicle tracks through the vehicle communication module to determine the approximate location of you, your mobile device or your vehicle, so that we can provide and improve our location services, navigation destination delivery services, emergency services, remote control or other services. In order to improve the quality of service, we will record when you dial the customer service hotline through the blue button.
0	If you agree to us providing vehicle data monitoring services in Section 1.5.3, we can collect your vehicle location information through in-app collection for data monitoring of new energy vehicles. The sensitive personal information we collect under the service scenario of vehicle data monitoring belongs to the personal information necessary for us to fulfill our legal obligations.
0	If you agree to us providing after-sales support service in Section 1.5.4, we can collect your ID number, driver's license information for binding vehicle, user account, maintenance and after-sales support service through in-app collection, user input or offline collection. You agree that we can collect your vehicle insurance and insurance policy information through offline collection, which can be used to provide you with after-sales claim service. In order to improve the quality of service, we will record after-sales service calls.
0	If you agree to us providing door-to-door pick-up and delivery service in Section 1.5.5, we can record it through in-app collection or offline collection.

0	If you agree to us providing vehicle replacement and used vehicle trading services in Section 1.5.6, we can collect your ID number , driver's license information and vehicle insurance information through offline collection to bind the vehicle and determine the condition of the vehicle, to provide vehicle replacement and used vehicle trading services.
0	If you agree to participate in the commercial promotion activities provided by us in Section 1.6.1, we can collect your ID card number , driver's religious belief , driver's license number and scanned copy of your driver's license through in-app collection, user input or offline collection, offline collection, or through user initiative posting content. You agree that we will collect your ID number and religious beliefs through user input for expert online counseling services.
0	If you agree to participate in the marketing survey provided by us in Section 1.6.2, we can collect your location and action track, ID number, and religious beliefs in offline scenarios through in-app collection, user input or offline collection, for the use of marketing surveys, questionnaires and customer behavior analysis, online and offline interviews.
0	If you agree to participate in the personalized recommended activities provided by us in Section 1.6.3, we can collect your driver's license number , front and back scanning copy of your driver's license , ID number and religious belief through in-app collection and user input, for the use of providing you with personalized recommended content and promotional information.

We will inform you of the identity and contact details of the new legal entity or organization, the reason for the transfer, the type of personal information involved, the possible impact and the continuing obligations of the recipient by appropriate means such as a pop-up window.
